EXPRESS PENALTY CLAUSE

If this application for admission to Membership is forwarded to ANICA and is not complete in all its parts, it will not be submitted to the approval of the Board of Directors; the applicant has the possibility of regularizing it by 31 December of the current year. If the data account has elapsed unnecessarily, the Secretariat Office will refund any amount paid within the following 90 days after deducting the costs for secretarial expenses equal to €50. After 31 December if the interest in joining is still alive, the applicant will have to submit a new application without the possibility of compensation for any fees paid the previous year, which, as mentioned, will in any case be refunded. N.B. The condition of ANICA member is acquired only after the application for admission, complete in all its parts and accompanied by the payment of the envisaged fee, is formally approved by the Board of Directors which, with a reasoned opinion, has the right to reject it. In the event of rejection, the Secretariat Office will refund the fee paid, withholding €50 for expenses. The Office will take care of this task within 30 days of the decision of the Board of Directors.

Legislative Decree n.196/2003 as amended (Privacy Code) and the European Regulation on the protection of personal data EU 2016/679 provide for the protection of individuals with regard to the processing of personal data. According to the indicated legislation, the processing of personal data of the members will be based on principles of correctness, lawfulness and transparency. We wish to provide some information regarding the methods and purposes of the processing of personal data

Purpose of the treatment

A.N.I.C.A. carries out the processing of personal data acquired by signing the application for admission as a member and subsequently for the execution of the institutional purposes of the Association as defined by the Statute, Regulations and legal provisions. The personal data processed relates to the Associate, if a natural person (if a minor, data of parents/guardians), and to the legal representative/partners/contact persons of the Associate, if a legal person.

Legal basis of the treatment

The legal basis of the processing is the execution of the contractual relationship of which the interested party is a part and the fulfillment of related legal obligations. The processing of contact data for sending information material is based on the specific consent expressed by the interested party, as is the publication of personal data on the Association's website (Repertoires and Guides).

Personal data categories and sources

The processing will concern categories of data such as: personal data, tax code, telephone and email contacts and other information collected during the provision of institutional activities and services to the member. No particular data will be processed pursuant to Article 9 of the GDPR. Personal data will mainly be collected from the interested party, some information may be taken from public databases.

Recipients of data communication

The data collected may be communicated, exclusively for purposes related to association activities and legal obligations, to third parties such as: Public bodies that manage national equine databases and third-party companies that support ANICA in carrying out their institutional activities. Personal data may be disclosed, subject to explicit consent, by publication on the institutional website and social spaces of A.N.I.C.A..

The data will not be transferred to non-EU countries. If it becomes necessary for institutional and legal obligations, the transfer will comply with the applicable legislation identified by Article 46 of the GDPR.

Data retention period

At the end of the associative relationship, the recorded data will be stored further for institutional purposes of management of the personal data history. The contact details will be used to send informative material until consent is revoked

Rights of the interested party

At any time, you may exercise, pursuant to articles 15-22 of EU Regulation 2016/679, by contacting the Data Controller at the addresses indicated, the following rights as an interested party:

ask for confirmation of the existence or not of personal data;

obtain information about the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the personal data have been or will be communicated and, when possible, the retention period;

obtain the rectification, integration and cancellation of data;

obtain the limitation of the treatment;

object to the processing at any time;

You may also file a complaint with the Privacy Guarantor in the event of irregularities found in the processing.

Mandatory or optional nature of the provision

The provision of personal data is optional but necessary for admission to A.N.I.C.A. as an associate. Consent to the publication of data and the processing of contact data for sending communications is optional.
